Re: FY – 22 Supplemental Budget – Information Only

Background

Last year the HRCTD Budget Committee and the Board made the decision not to include the Gorge to Mountain services in the final budget, but to address it through a supplemental budget once a decision had been made regarding funding. Staff began finalize the budget and was ready to present the finalized supplemental at the March Board meeting, but was recently approached by ODOT about providing the Multnomah Falls Shuttle this year (beginning June). Staff is waiting to finalize the FY-22 Supplemental until the Board has made a formal decision about providing the Multnomah Falls shuttle and assessing whether they want to purchase a Trolley this year.

Attached is a detailed overview of the current expected changes to the budget.

Revenues

The budget saw changes to revenues in three areas:

- Decreased in Federal Assistance due to a delay in vehicle delivery (Decrease \$689,500)
- Increase in State Assistance (Potential increase \$267,000)
 - Minimum would be \$67,000 for Gorge to Mountain, if the Board approves Multnomah Falls Shuttle, we estimated another \$200,000 in revenue would be needed this year to ready vehicles, hire drivers and operate the vehicles.
- Anticipated increase in Federal CARES ACT funds. (Potential \$160,000)
 - CAT will ask for another \$160,000 this year to cover wage increases, maintenance, marketing and other COVID related expenses.

The budget saw changes to expenditures in four major areas

- Operations Expense (Potential \$210,000 increase)
 - Preventative Maintenance (related to COVID) we estimate an additional \$40,000 in additional maintenance due to delay in new vehicles and if the Board approves the MF Shuttle, we would anticipate another \$50,000 to ready vehicles for service.
 - Insurance addition of new vehicles due to MF shuttle service (\$10,000)
 and due to COVID (\$10,000)
 - Marketing (potential \$100,000 increase) Staffing issues in early summer led to an increase in the use of outside consultants to handle marketing efforts. Vehicle wraps due to purchased vehicles related to COVID delays, TMP and the potential for additional marketing expenditures related to the MF shuttle (signage, wraps, marketing, other).
 - Contract (\$20,000) CAT signed a contract with MCEDD for LINK to provide the Hood River to The Dalles services. This ultimately decreases the overall cost of the service for CAT, but needs inclusion in the budget.
- Capital Expenditures (Decrease \$689,500)
 - Delay of new vehicle delivery (related to COVID)
 - May want to keep more funding in to cover Trolley
- Personnel Expenses (Potential \$300,000 increase)
 - New contract & wage rates with the Driver's Union (related to COVID) we estimate about \$80,000 related to G2M services about \$100,000 related to wages and, if the Board approves the MF Shuttle, we would anticipate another \$120,000 in direct services wages for added services

Meeting Minutes

1. Call to Order

Lara called the Board of Directors Meeting to order at 4:01p.m.

2. Roll Call:

Tiah Mayhew took roll call. Lara Dunn (Board Chair), Leti Moretti (Board Vice-Chair), Darrell Roberts (Secretary), Greg Pack, Jeff Helfrich, Megan Ramey, Meghan Larivee Quorum was met.

3. Approval of February Board of Directors Minutes

Lara asked for comments on the approval of the February 16th, 2022, minutes. Darrell stated that a correction was needed under the Executive Directors Report on the last bullet under Expenses. The dollar amount was missing. Patty will get that updated.

4. Public Comment

No public comment was made.

5. Monthly Financial Report - Teresa Gallucci, Our Team Accounting

Teresa gave a brief overview of the financial report. The cash on hand at the end of February is \$1.5M, this is roughly 287k more than last year during this time. The revenue year to date is 1.5M and the budgeted amount is 2.3M. We are still in a good place.



6. Resolutions & Action Items- Patty Fink

• Title VI Report – Patty explained that every three years we are required to do a new Title VI, which is a civil rights requirement for the federal transit administration. It requires that we highlight our commitment to ensuring that everyone has equal access to transit service. We highlight what actions we are taking within the district to ensure that is happening, and as a part of that we also highlight how we are reaching out to those individuals who have limited English proficiency and we have a strong commitment to civil rights. Patty mentions how that has been highlighted in the new plan from 21-24, a draft copy has been provided to ODOT and they were so impressed with it that they were going to use it as an example for training purposes. Patty felt very proud about that. Approval and signature from the board is necessary.

Motion:

Leti made a first motion to approve the Title VI, Jeff Helfrich seconded that motion. Approved by all.

Multnomah Falls Service and Permitting – Patty Fink

Patty reviewed the ODOT waterfall permit program memo. She also gave a brief overview of potential route options for the board to review from Gateway to Multnomah Falls. Staff at CAT prefer the third option as it connects with Hood River County.

Megan R. asked about the potential confusion between this service and the GCE services. She asked if CGE would still stop at Multnomah falls, Patty confirmed that CGE would still stop allowing for more frequent stops to service the area for the summer. She also mentioned that the buses would be differentiated to avoid confusion.

Greg asked about the fare options for this service, Patty explained that the Gorge pass will be accepted, also the online \$15 day pass is available, and riders can use the fare box for cash payments.

Jeff asked how this would be affected with the driver shortage. Patty explained that there has been an influx in class B applicants, and we have hired 2 new employees for summer positions. She mentioned that Mt. Hood Meadows drivers might be available to help, as well as school bus drivers. Jeff then asked how hiring temporary drivers would affect our contract with the union. Patty explained that we can hire up to four temporary drivers without impacting the union contract.

Darrell asked if the buses being used for this service are bought or if they are being loaned. Patty confirmed that they were purchased.

The board was not ready to vote as they had additional questions and requested a special meeting on March 29th, 2022.

Motion: Greg made a first motion for a special meeting; Leti seconded this motion. Approved by all.

Trolley- Ty Graves

Ty explained that the trolley we leased previously is not available this year. The city of Hood River has pledged 25k towards the purchase of a new trolley. We are asking for up to 50k from the board to purchase a trolley that can be used until a grant is available for an electric trolley. We asked ODOT if we could amend an existing electric vehicle order, but that request was denied. At this time, we are probably 2 years out from purchasing an electric trolley. Approval from the board is needed for the 50k that is needed for the purchase of a Trolley.

Darrell asked how many trolleys were being purchased as it seemed a bit unclear on the agenda. Ty and Patty clarified there is just one trolley being purchased, that staff identified 2 options that were available.

Jeff asked what the resell possibility was so when we are able to purchase an electric trolley, those funds could go towards that purchase. Ty stated that trolleys seem to hold value well and we would be able to sell it and depending on the grant available, we could use it as a match or funds towards purchasing.

Motion: Greg made a first motion to approve the 50k funding for a trolley. Megan R. seconded that motion.

Approved by all.

7. Operations Manager's Report- Ty Graves

- a. Ty gave a brief overview of the operations manager report.

 Employee of the Month is Richard Durham. He started as a chainer and recently obtained clearance to drive, Class B. Richard is a great asset to CAT and he is always finding work to be done.
- b. Performance Report, the safety score has been slightly the same. There has been zero crashes and three harsh events, they were all harsh turns. Ty mentioned that the miles and times driven have increased. The on-time performance has stayed the same. Fuel cost has increased this month. There have been zero customer complaints.

8. Transit Master Plan Update- Patty Fink

Patty went over the TMP, the surveys have launched and there were 110 survey responses. 74% of those live in Hood River, 65% have never used CAT. There was a small response in Cascade Locks and 24% said that the current system does not fit their needs, they would like expanded routes and hours particularly evenings and weekends and more identified bus stops. Of those survey responses about 24% were from the Hispanic community, we are working on outreach to provide more diverse feedback. Patty also mentioned that there was good feedback from the technical advisory committee and citizens advisor committee. Most people appreciated the easy-to-read Existing Conditions report. Overall, the project is moving at a good pace.



9. Executive Director's Report- Patty Fink

a. Discuss Supplemental Budget

Patty gave a brief overview of the supplemental budget hearing that will happen next Month. There will be a few decreases due to the vehicle deliveries. She mentioned how there will be an opportunity to apply for additional federal cares act funds and she expects to see an approval by the end of the year. Patty mentioned how there will be increases in the state assistance related to the Columbia Gorge Express services. Operation expenses have had increases including preventative maintenance and insurance due to adding additional vehicles and marketing due to staffing issues during COVID. Patty mentioned a slight increase in the contract signed with MCEDD that includes the weekday trips provided from Hood River to The Dalles. The capitol expenditures are going to be reduced. Personnel expenses have a potential of a 300k increase due to the updated union contract wage increase.

Columbia Area Transit Financial Statements Variance Analysis Period Ending: March 31, 2022

Balance Sheet

<u>Cash Availability</u> - Total available cash at the end of March 2022 was \$1.3m. This is approximately \$210k less than last month but \$39k more than March 2021.

Accounts Receivable – All outstanding invoices due to CAT have been paid.

<u>Grants Receivable</u> – The total Grants Receivable balance at the end of March was \$362k, which is \$148k more than last month. It should be noted that Q3 grant requests will be submitted in the next few weeks and payment for the various grant receivables will be received.

<u>Prepaid Expenses</u> – Total prepaid expenses at the end of March were \$32k. Approximately \$5k in expense for the month was recognized.

<u>Accounts Payable</u> – The amount due to vendors and not yet paid at the end of March was \$17k. All open invoices were paid in the first check run issued in April.

<u>Deferred Revenue</u> – All deferred revenue has been earned and recognized.

Income Statement

<u>Revenue</u> – Total revenue earned YTD through the end of March was \$1.6m, which is \$336k more than FY21 at this time. The revenue amount budgeted through the end of March was \$2.5m. Of the \$846k variance, \$650k is due to capital grants for which the purchases have not yet been made and therefore the revenue has not yet been earned. The remaining variance is made of multiple grants that have not yet been fully drawn as planned.

COG Fuel – Fuel expense YTD through the end of March was \$116k. The amount budgeted was \$190k. Actual expense was \$74k less than budget.

<u>COG Operations</u> - Preventative maintenance, tires, shop supplies and bus repair expenses at the end of March totaled \$102k, which is \$63k more than prior year at this point in the year and \$43k more than the amount budgeted due to significant repairs for a couple of the buses..

<u>COG Communication</u> – Dispatch, GPS software and cellular data expenses for the year, through March were \$34k. This is \$11k more than 2021at this time, and \$10k more than budgeted for this time of the year. The total annual budget is \$39k for the year and \$5k is available to spend before the end of June 2022. There were several unplanned purchases of radios for older buses that were purchased that required communication upgrades.

<u>COG Driver Expenses</u> – As of March 31st driver expenses were \$7k. This is \$1k more than the amount incurred in FY21 at this time but \$3k less than the amount budgeted.

<u>Advertising</u> – Advertising expense through the end of March totaled \$75k. \$40k has been budgeted for the full year. This is significantly over budget to due a variety of factors, some planned and some not (Gorge to Mountain marketing, staffing, bus wraps).

<u>Grant / Contract Match Funds</u> – The match funds applied for the year through the end of March totaled \$44k. The budgeted amount for activity so far in FY22 was \$32k resulting in a variance of \$12k.

<u>Gross Profit</u> – Gross profit for activity through the end of March was \$1.2m which is \$247k more than last year at this time, but \$889k less than the amount budgeted. Again, this variance is due to the capital grants referenced above not yet having been drawn against and grant draws not yet having been fully processed.

Administrative Expense – Administration expenses at the end of March 2022 totaled \$177k which is \$69k more than last year at this time and \$20k more than the amount budgeted for this point of the year. The variance is most significantly attributable to the building maintenance, with YTD expenses of \$53k due to heating/air conditioning repairs earlier this year and water damage that occurred in February. Due to these unexpected expenses, the budget for Building Repairs & Maintenance amount will be adjusted when the Supplemental Budget is submitted.

<u>Personnel</u> —Personnel costs so far this year totaled \$920k which is \$277k more than last year. It should be noted that FY21 was unusually low due to Covid layoffs. The amount budgeted for expenses through the end of March 2022 was \$977k, leaving a positive variance of \$46k even after the recent wage increases that occurred in February.

<u>Capital Outlay</u> – A total of \$76k was expended on capital purchases through the end of March. The amount budgeted was \$834k, of which, the substantial amount was to be directed toward the purchase of buses. During the month of March, three 40 foot low-floor buses were purchased in the amount of \$3,333 each

<u>Net Income</u> – YTD Net income at the close of close of March 2022 was \$51k, which is \$162k less than FY21 at this time and \$46k less than the amount budgeted.



Q22 Which age group do you belong to?





Background

As part of the Transit Master Plan (TMP), I asked Paul Koch, a political consultant to conduct interviews with local and regional stakeholders on CAT's current role as a regional transit provider and how stakeholders view of our long-term role within the Gorge and the National Scenic Area (NSA).

A summary of those interviewed and their response to a series of questions is attached. In addition, the report lays out some considerations and recommendations for CAT – many of which have implications as we develop new goals and priorities for the district in our transit plan.

Report Summary

The upshot is CAT is well respected within the Gorge and is seen as an influential leader on transit within the area. Most respondents understand our unique position within the Gorge and feel CAT is currently the best equipped provider to play a leading role in the planning and provision of transit services within the Gorge.

There is a clear understanding by most respondents that a coordinated and comprehensive transit and transportation network is key to addressing a variety of growing issues/concerns within the NSA.

Questions

The report raises some questions for the CAT Board and District CAC as it is developing its goals and priorities for the transit master plan including:

- Does the Board want CAT to continue to play an important role in the planning and provision of regional transit services?
- Beyond current efforts, how does the Board envision the continued coordination with other Gorge providers?



• Are there advantages (funding, access, other) to the District, Hood River County residents or local transit or ridership goals to pursue a consolidated transit system or structure and if yes, under what conditions.

TRANSIT WITHIN THE NSA

INTRODUCTION:

CAT contracted for a regional assessment of CAT's role as regional transit provider in the Gorge with a particular focus on the National Scenic Area (NSA) designated areas. The assessment was conducted by Paul Koch under contract with CAT and was completed during the month of March 2022.

Initially there were 22 different target individuals and agencies for the interviews. Of the targets, 20 total interviews were completed and utilized for this final report. Interviews included the following individuals and organizations:

QUESTIONS INCLUDED IN THE ASSESSMENT:

The following questions were asked of the assessment participants. In some cases, certain questions were not relevant and were not asked.

- 1. What are the transportation priorities in your jurisdiction?
- 2. What do you see as the role of transit within the NSA?
- 3. What plans are you making for parking lots?
- 4. Do you see a need for consolidated transit services within the NSA?
- 5. If yes, what does that look like?
- 6. Do you see CAT playing a role in delivering your transportation services?
- 7. In your state government, who do you work with or call regarding transportation?
- 8. What is missing or never discussed regarding transportation in your community?

INTERVIEW SUMMARY:

- 1. Question: What are the transportation priorities in your jurisdiction? Overall, the responses focused on:
 - Hood River Bridge and Bridge of The Gods Replacement/Repairs
 - Walkability
 - Bicycling
 - Traffic Calming
 - Park and Ride Locations
 - Expanded Trailhead parking
 - Emergency, Safety & Congestion Mitigation Planning
 - Roadway maintenance and repairs

Transit Focused responses were:

- Expanding transit options for employees
- Expanding transit options for recreational users and getting NSA visitors out of cars and reducing visitor congestion
 - Trailheads
 - Waterfront
 - Communities
- More transit service overall and greater frequency
- More Park and Rides
- Expanding service to Mt. Hood & making connection around the mountain
- More two state connections to get people to work & shopping
 - Enhancing bridge access
- Looking at railroad options (Amtrak frequency)
- Focus on equity for those without cars (weekends and evenings)
 - Seniors and other transit dependents
 - Low income
- Enhanced coordination among providers

2. Question: What do you see as the role of transit within the NSA?

The majority of the interviewees felt that transit had two equally important roles to play within the NSA:

- 1) Providing access for local residents to healthcare, education, employment, recreation, entertainment and other activities, reducing transportation costs connecting gorge communities and getting local folks access to/from Portland/Vancouver area:
- 2) Increasing the number of people who use transit to access the NSA, relieving congestion and safety in communities along key through routes (e.g. SR14, & I-84) and at trailheads. There was a strong sense that transit will be a key player in managing and facilitating livability and future growth in the NSA and stressing coordination and linkages between transportation access and new developments.

3. Question: What plans are you making for parking lots:

Most interview participants were relying on others to provide parking although a couple of respondents have plans for more parking within their communities, are thinking about parking structures or are currently building more lots.

4. Question: Do you see a need for a consolidated transit service within the NSA?

Most respondents felt that consolidation of transit services in the Gorge could be an effective way to focus on the long-term needs, avoid duplication and enhance efficiency. Though, a few folks expressed concerns regarding consolidation and the potential loss of local control as well as the potential "insurmountable government" barriers. Despite concerns there was a strong feeling that now is the time to have those discussions and identify and where possible overcome the barriers by focusing on the needs.

- Several respondents noted that the Gorge Regional Transit Survey and other transportation plans and studies could assist in helping the region make a decision regarding consolidation.
- There was a variety of opinions on what consolidation might look like in the Gorge and how it would be structured so that local communities still had an important voice in priorities and expenditures.
 - A Bi-State approach that leverages the NSA region- with one responsible agency (potentially CAT or MCEDD).
 - A partnership approach and enhanced collaboration between all agencies.
 - A fostering of private sector operators to take on a larger role, particularly around events and the influx of summer visitors.

There was general agreement that a first step was a coordinated and connected transit system. Key to achieving this step was enhancing the collaboration (e.g. working together) between existing providers,

5. Question: If yes (to consolidated service) then what does it look like?

All the respondents were unsure regarding what consolidation might look like. The feeling however was that stronger collaboration and moving toward the aspirational goal of consolidation would work out a lot of the details and overcome many of the barriers. All the participants were willing to work together to make those discoveries.

6. Question: Do you see CAT playing a role in delivering your transportation services?

Most of the interview participants were positive about CAT and could see CAT in a lead role. Many also felt that CAT was best equipped to play a lead role in transit services in their community.

7. What is missing or never discussed regarding transportation in your community?

- The need for a wholistic approach, how we create what we really need and not be stuck in the past or fearful of two state solutions.
- The summer crunch with all its people-how can we effectively manage this increase to minimize the impacts to our communities.
- How to maximize the potential we have through the NSA-creating one consolidated transportation network within the NSA.
- Development of a long-term plan (20–30-year vision) that we can all commit to carry out and sticking with it in serving the people and region.
- Accepting that this is one economic region and that there is a bi-state transportation connection but that there are funding priorities and other differences.
- Making transportation work for all of us and ensuring that funding is sustainable over time.
- Integrating emergency response and management needs into all transportation plans.
- Creating transportation equity and subsidizing low-income residents with a particular focus on rural areas.

 Identifying ways to involve business and school district interests in the discussions around identifying and planning for transportation needs and solutions.

NOTE: There was an original question 7 that dealt with state contacts regarding transportation. There was not much response to that question, so I eliminated the few comments from this final report. Most respondents knew it was either ODOT or WSDOT.

CONSIDERATIONS AND RECOMMENDATIONS:

Based on the many interviews and comments, here are some recommendations for consideration to begin to prepare for the transportation future within the NSA. This will be challenging; however, it appears that the time is right for everyone within the NSA to come together and deal with these issues in a very comprehensive way. It is valuable to know that attitudes and willingness have significantly changed over the last 4-5 years. Driven in part by the huge increase in visitors and events, this willingness should be capitalized on and used to better serve the transportation needs of the region. There is interest in a strong long-term vision-based strategy. And with the new marketing programs aimed at bringing even more people to the Gorge, the time is right for greater collaboration and long-term effort.

- 1. There is strong support and interest in the Gorge Regional Transit Strategy (GRTS) being the right planning process to address the future vision, organizational structure and funding opportunities for transit in the Gorge (both inside and outside the NSA). However, there is also a desire to make sure that transit needs are a part of the of the larger bi-state transportation planning effort and funding strategy.
- 2. This GRTS process allows the region a golden opportunity for the many jurisdictions to look long range, create the vision and strategies to meet the broader transportation goals of the future including parking management, transit, roadway investments, bike and pedestrian access. This broader process should be carried out in a joint format where MCEDD, OneGorge

and the Southwest Washington Regional Transportation organization along with the Gorge Commission offer a Gorge transportation planning conference focusing on the specific transportation needs of and within the NSA, where the multiple transportation planning processes currently underway or just completed plans could be identified, integrated and consolidated into one long-range vision.

- 3. Accept the idea that implementation of this long-range vision will be difficult and will require everyone to stay focused on the public need and what is best for both the environment and the economy of the NSA. There are barrier issues to be faced for sure. But there seems to be a growing consensus that identifying the opportunities and benefits of using the NSA overlay as a coordinating element instead of focusing on differences in the two states approach could be highly successful.
- 4. Include both Governors in this effort along with the members of the Congressional Delegations from both states. Through the Gorge Commission, the NSA is directly connected to each Governor's Office. You should take full advantage of this connection. State Legislators in both states should also be briefed and informed to be of assistance to the effort. The politicians will be very critical to long term success in the process as you move forward.

Re: RFP Auditor

Background

The Board will remember that the Board released in RFP for the 2021 audit in June of last year and received only one response – from the current Auditor, Richard Winkle. Given the short-time frame the Board approved a contract with Mr. Winkle for the FY2021 audit but directed staff to reopen the bid for an Auditor in early spring. HRCTD released an Auditor RFP in February to several firms for a three-year contract. We received one response from a local firm, Friend & Reagan. P.C in The Dalles. The additional firms that were asked to Bid indicated they were at capacity and would not bid and/or no response was returned.

The Auditor is commissioned by and reports directly to the Board, so the Board should feel comfortable with the firm selected. Attached is the proposal.

- 1. The Board can vote to approve the contact with Friends & Reagan at the May Board Meeting.
- The Board can ask staff to set up a formal (or informal) interview with the full Board or a Board Committee who would make a recommendation formal recommendation to approve or rerelease the RFP at the May Board Meeting, or
- 3. The Board could direct staff to re-release the RFP

Staff Recommendation

Given that responses have been limited and the FY2022 audit should begin in September, we recommend either option 1 or option 2.
